**Subject:** Concerns regarding the invitation extended to minister Amichai Chikli to participate in a panel you are hosting at the European Parliament

Dear Honourable Members of the European Parliament,

On behalf of families of Israeli hostages and leaders of European Jewish communities, we write to express our profound concern regarding the invitation extended to Minister Amichai Chikli to speak at your event addressing antisemitism, to be held on International Holocaust Remembrance Day, 28 January 2025.

Minister Chikli's record, especially his recent actions within the government, renders him an inappropriate representative for such an important occasion, dedicated to remembering the atrocities of the Holocaust and advancing the values of human dignity and justice.

## **Opposition to the Hostage Rescue Agreement**

Minister Chikli voted against the hostage rescue agreement, which sought to save individuals held in captivity under appalling conditions for over 470 days. This agreement, widely supported by the European Union, the international community, and even the very government in which Minister Chikli serves, represented a critical effort to bring the hostages home and provide humanitarian relief to Gaza's population<sup>1</sup>. His opposition to this agreement is in stark contrast to the values of empathy and solidarity that should guide us, particularly on Holocaust Remembrance Day.

## **Support for Far-Right European Politicians**

Minister Chikli has repeatedly expressed support for far-right politicians such as Marine Le Pen (France), Santiago Abascal (Spain), Jimmie Åkesson (Sweden), and Calin Georgescu (Romania), whose rhetoric and policies often undermine the fight against antisemitism and hatred<sup>2</sup>. Such alliances call into question his credibility as Israel's Minister of Diaspora Affairs,

and his presence at the conference risks legitimising figures and ideologies that conflict with the core objectives of the European Parliament.

## Support for the Idea of Ethnic Cleansing

Minister Chikli has openly supported the expulsion of populations from both Gaza and South Lebanon, as documented in his public statements<sup>3</sup>. Such a position, which is deeply troubling, is incompatible with the human rights and dignity that should underpin Holocaust remembrance and education.

Minister Chikli's extremist and divisive positions do not reflect the values or voices of the broader Israeli public or global Jewish communities. On the contrary, his participation in this event risks overshadowing the vital message of the conference and undermining the credibility of the European Parliament's efforts to combat antisemitism and hatred.

We call on you, as organisers of this important event, to reconsider Minister Chikli's participation. His presence does not serve the memory of the Holocaust or the shared principles of justice and tolerance that guide both your efforts and ours.

We remain committed to supporting the European Parliament's fight against antisemitism and are eager to collaborate to ensure this event serves as a platform for unity and remembrance.

# Family members of Oct 7 Hostages and victims (in alphabetical order):

- Ayala Metzger, daughter-in-law of **Tami and Yoram Metzger** who were kidnapped from Nir Oz. Tami was released in the humanitarian deal. **Yoram** survived over 100 days and was then murdered in captivity.
- 2. Ayelet Hameck Relative of **Guy Illouz**, who was kidnapped from the Nova Music Festival, injured during the abduction, and later died in captivity due to lack of medical care
- 3. Barak Ben-Ezra Nephew of **Avraham Munder**, who survived over 100 days in captivity but was murdered by Hamas. Also cousin of **Roi Munder**, murdered in captivity,

- and nephew of Ruti Mondor and **Karen Munder**, freed with Karen's son, **Ohad Munder**, in a life-saving deal.
- 4. Prof. Boaz Atzili Cousin of **Aviv Atzili**, a member of Kibbutz Nir Oz's emergency team who fell defending the kibbutz, whose body was taken. Aviv's partner, **Liat Atzili**, was kidnapped and later freed.
- 5. Carmel Avend, relative of **Raz Ben Ami** who was kidnapped and brought back in the humanitarian deal and of **Ohad Ben Ami** who is still in Gaza.
- 6. Carmit Plati-Katzir Sister of **Elad Katzir**, who survived over 100 days in captivity but was murdered, and daughter of **Rami Katzir**, murdered in the kibbutz, and **Hana Katzir**, who was freed but died shortly after her release due to the effects of captivity.
- 7. Dvora Idan Mother of **Tsachi Idan**, kidnapped from Nahal oz who is still in captivity.
- 8. Efrat Machikwa Niece of **Margalit Moses (78)**, who was freed in the life saving deal, and **Gadi Moses** (80) who is still in captivity.
- 9. Gal Goren Son of **Avner Goren**, murdered in Kibbutz Nir Oz, and **Maya Goren**, kidnapped and later murdered in captivity.
- 10. Gefen Sigal Ilan Daughter of **Clara Merman**, kidnapped with family members from Kibbutz Nir Yitzhak.
- 11. Gadi Amichai Nephew of **Yocheved Lifschitz**, who was freed after 17 days in captivity, and brother of **Oded Lifschitz**, still in captivity.
- 12. Inbar Zeleski Relative of **Ohad Ben-Ami**, still in captivity, and **Raz Ben-Ami**, freed in a life-saving deal.
- 13. Ifat Kalderon, cousin of **Ofer Kalderon** who was kidnapped with his two children Sahar and Erez Kalderon who were returned in a life saving deal after 52 days. **Ofer** is still in Gaza.
- 14. Dr. Jonathan Guttman Cousin of **Evyatar David**, kidnapped from the Nova Music Festival and still in captivity.
- 15. Lee Dan Relative of **Ofer Kalderon**, kidnapped with his children **Sahar and Erez** (freed in the life saving deal after 52 days). **Ofer** remains in captivity.
- 16. Dr Magen Inon, bereaved son of **Bilha and Yakovi Inon** who were murdered on October 7th at their home in Netiv Haasara
- 17. Maayan Sherman Mother of **Ron Sherman**, kidnapped from the Erez Crossing and killed during a military operation.
- 18. Maayan Sigal-Koren Daughter of **Clara Merman**, kidnapped with relatives from Kibbutz Nir Yitzhak.
- 19. Maoz Inon, bereaved son of **Bilha and Yakovi Inon** who were murdered on October 7th at their home in Netiv Haasara
- 20. Meirav Svirsky Sister of **Itay Svirsky**, kidnapped from Kibbutz Be'eri, survived 99 days but was murdered. Also daughter of **Orit and Rafi Svirsky**, murdered in the attack.
- 21. Moshe Lotem Father of **Hagar Brodutch**, who was kidnapped with her children and freed after 49 days.
- 22. Nathalie Smith, relative of **Tal Shoam** who was kidnapped with his entire family from Beeri. Other family members were released in the life saving deal: **Dr. Shoshan Haran** (mother in law) **Adi Shoham** (wife), **Yahel and Nave Shoham** (children). **Tal Shoham** is still captive in Gaza. Four other family members were murdered.

- 23. Neta Heiman Mina is the daughter of **Ditza Heiman** who was kidnapped from her home in Kibbutz Nir Oz.
- 24. Noa Atzili Cousin of **Aviv Atzili**, a member of Kibbutz Nir Oz's emergency team who fell defending the kibbutz, whose body was taken. Aviv's partner, **Liat Atzili**, was kidnapped and later freed..
- 25. Noam Dan Cousin of **Hadas Kalderon**, whose children **Sahar** and **Erez** were freed in a life saving deal, while their father, **Ofer Kalderon**, remains in captivity.
- 26. Noy Katsman Sibling of **Dr. Hayim Katsman**, murdered on October 7, 2023.
- 27. Osnat Sela-Weinberg Sister of **Eyal Sela**, kidnapped from Kibbutz Nir Am and still in captivity.
- 28. Rachel Moses Sister in law of **Gadi Moses**, still in captivity. Niece of **Margalit Moses** (78), who was freed in the life saving dea
- 29. Sari Gat, aunt of **Carmel Gat** who was kidnapped from Beeri until she was murdered in captivity. She is also the sister in law of **Kineret Gat** who was murdered.
- 30. Shai Moses nephew of **Gadi Moses**, who remains in captivity. Niece of **Margalit Moses** (78), who was freed in the life saving deal
- 31. Sharone Lifschitz Daughter of **Oded Lifschitz**, an 85-year-old kidnapped brutally from his home in Kibbutz Nir Oz, and of **Yocheved Lifshitz**, freed after 17 days in captivity.
- 32. Shira Susana Sister of **Amit Susana**, kidnapped from Kibbutz Kfar Aza and later freed.
- 33. Shmuel Brodetz Relative of **Hagar Brodetz**, freed with her children.
- 34. Snir Dan, brother of **Kineret Gat** who was murdered in Beeri and cousin of **Carmel Gat** who was kidnapped alive from her parents' house in Kibbutz Beeri on October 7 and was murdered shortly before the IDF found her body on 1 September 2024 (11 months after she was kidnapped).
- 35. Talma Amichai Sister-in-law of **Yocheved Lifschitz**, who was freed, and sister of **Oded Lifschitz**, still in captivity.
- 36. Yael Ofek-Or Cousin of **Dror Or**, kidnapped with his children, later freed while Dror was murdered.
- 37. Yechiel Yehoud, father of **Arbel Yehoud** who was kidnapped from Nir Oz and of **Dolev Yhehoud** who was murdered.
- 38. Yehuda Cohen Father of **Nimrod Cohen**, an Israeli soldier kidnapped on October 7th.
- 39. Yotam Cohen Brother of **Nimrod Cohen**, kidnapped on October 7th.
- 40. Yotam Kipnis son of Eviatar and Lilach Kipnis, murdered on Oct 7.
- 41. Zahiro Shahar Mor, nephew of **Avraham Mundar** who was kidnapped from Kibbutz Nir Oz, survived over 100 days in captivity and was murdered by Hamas. He is also the cousin of **Roy Munder**, who was murdered; nephew of **Ruti Munder**, cousin of **Keren Munder**, who were released after 49 days together with **Ohad Munder**, Keren's son, in a life-saving humanitarian deal.
